

The 39th. AGM TOOK PLACE AT 8 PM on Wednesday 19 th. May 2004 at BENGEO SCHOOL when we welcomed a larger than normal turn out of supporters, although we are aware that overwhelming support is usually evident only when something occurs which threatens the quality of residents' every day lives, especially where their properties are concerned!

We had also hoped a few Councillors would come along and support the meeting but we are grateful to SALLY NEWTON for her presence and answering questions from residents on grass cutting. Councillor Newton said that the Council sub-contractors were only supposed to cut the lawns twice in every season.

The frequency of cuts has certainly improved from a year or two ago and have been recently carried out immediately following a resident's 'phone complaint.( When, we wonder, are the Council going to remove the ugly stump of the tree blown down by storms in The Wick and now sprouting new shoots?)

Thanks were expressed to Ann of the 'Shopping Basket' who supplied the food and wine.

We were also pleased to have GEORGE SANDELL of C.A.G.E. give us all an update on the reemergence of the growing gravel extraction problems and reminding those of us who are regularly taken on 'walkies' by our beloved pooches over the picturesque rolling countryside of Waterford Heath that, but for all the efforts of local groups (including our own), the area would still be used for gravel extraction!

Many of the paths are strewn with dog faeces. Sadly, many walkers almost seem to get some perverse pleasure in leaving their best friend's deposit, making it extremely unpleasant for the rest! #### RURAL CODE

The new code stresses that all who visit the countryside should respect it, protecting plants and animals, taking litter home and keeping dogs under close control.

The bogus collectors bear a name very similar to Age Concern.

And, for your own safety, do NOT buy goods or services from doorstep traders, unless you are absolutely certain that they are strictly kosher! Trading Standards officers receive many complaints from people who have been 'conned' by characters persuading them to buy goods or services that they did not need nor could afford. The good news is that if you have bought or agreed to have work done you STILL may be able to cancel.

#### THE WICK

There are many improvements we would all like to see on this estate. High on this list is THE WICK pavements, the surfaces of which present a formidable walking nightmare for anyone with slight disabilities.

Like many other roads, with all the digging up and filling in for such things as cable and other installations over the years it has become a series of humps, bumps and irregular shapes.

We are at present endeavouring to get the Council to rectify the situation.

The GOOD news is that the Council have at long last promised that pot holes in the uneven roads will be repaired on a permanent basis, rather than the present system which never seems to withstand heavy winter frosts, etc.

#### NEIGHBOURHOOD WATCH

Houses left with windows and back doors open as well as garage and shed contents have been targeted by burglars this summer.

Please ensure that outbuildings, as well as the main house, are kept locked and any items of value are security post code marked for possible identification purposes later on.

The Government say (!) crime has dropped considerably over the UK lately and EAST HERTS has always been one of the top crime-free areas. Sadly, according to reports we no longer hold that enviable position which means we now have to be even more vigilant when leaving the property unattended.

Operation Guardian is a new anti-crime initiative and the police say that the increase is mainly in travelling crime because of the motorway network and the A10. People come into the area from London and Bedfordshire and steal car keys from inside homes and drive the cars away.

SO - keep your car keys out of sight!
As well as securing all buildings, always ask
neighbours to keep an eye on things for you when
you are absent—on a reciprocal basis of course!
A car left in an otherwise empty driveway can
sometimes be a deterrent, although the safest place
for it is in the garage!.

#### **Proposals for future COUNCIL TAX**

As if local residents haven't been stung enough already by above-inflation increases in council tax, more increases are envisaged! Homes are placed into one of eight bands according to their value, and some of the houses on the estate may have to suffer increases in the region of £1,000 a year!

Many elderly residents have received very minor increases in their state pensions (£1. per week?) and, if their savings are over £16,000 then - tough luck —they may get no assistance towards paying this iniquitous tax. In fact a person who may be managing on the State pension with meagre life savings of, say, £20,000 may have to dig into this just to pay their rate bill until their savings quickly whittle down to £16,000 when they can then claim relief.

Bands are to be renewed in 2007 and would take into account the huge rise in property prices in the last decade.

It is proposed that homes worth £90,000 would see an 18% cut in their rates bill (hardly any of us!)

Those with houses worth more than £340,000 may be hardest hit.

Is it fair that many residents may have to pay a higher and higher proportion of their low fixed incomes on ever rising council taxes on their own homes? They have had no hand in bringing about these increases in value and derive no income benefit from their property.

DO NOT forget that sole occupants are entitled to a reduction of 25% in their council tax bill. Apparently over £580 million remains unclaimed each year!

DO NOT lose out on entitlements to relief. Contact the Council's Benefits Service on freephone 0800 373 852 and find out whether YOU may have a slice of that unclaimed cake!

## SCHOOL PLAYING FIELD and PLAY SPACE

We are assured that the above green belt fields are Sacrosanct and will NOT be used for building land, although the spare field in between could!

Although this is being taken out of the green belt for reserve housing for 70 new dwellings, we understand that it is unlikely under present plans that this could happen for 7 years - at least, providing Government housing requirements are met.

(Let's hope they are!)

#### **FLY TIPPING**

A burnt out wreck of a vehicle lies on some spare land.

Baghdad...Palestine....?

Actually....NO. This is a blot on the lovely landscape of the North Waterford Heath where, once again, a car has been dumped and set on fire.

Some youths are pelting it with stones and climbing over it.

Fly tipping is illegal and offenders can be prosecuted and face up to a £20,000 fine or imprisonment.

Fly tipping is dangerous and anyone who witnesses—or even suspects—the act of fly tipping should inform the police immediately.

10,000 more brown wheelie bins are being sent to homes in East Herts for the purpose of recycling GARDEN WASTE, although not yet to Hertford

# PLANNING APPLICATION –LAND ADJACENT TO No. 6 DESBOR-OUGH CLOSE

The Green and Pleasant areas in and around our once rural County Town are fast becoming a 'concrete jungle' with every inch of spare land being built upon, the object being of course to meet the desperate need for housing.

Mind-boggling figures like 200,000 houses (and rising!) over the next 12 years mainly in OUR part of the S. East alone.

The draft local plan allows for many changes to the existing green belt although concentration will, they say, be on *brownfield* sites.

Land off Sacombe road will also be released from the Green belt (see also article on proposed development )

Whilst we do not normally involve the Association in *individual* Planning Applications, the one for two four-bedroom detached properties in the wooded copse and 'spare' land in Desborough has caused a huge number of written objections.

As it is a development which, if permitted, would alter the whole appearance and amenities to this part of the estate we feel that it is against the wishes of the majority and have therefore added our support to those objecting.

At the time of going to Press arguments are going on about wildlife, trees, etc. and it is not at all clear as to the eventual outcome, so we are monitoring the position closely.

#### SENSELESS PARKING!

We hate to be repetitive BUT .....

Earlier in the year a fire engine was delayed getting to a blazing van by cars parked in a narrow road.

Once again, please survey where you have parked and only leave your car when you are satisfied that all vehicles, especially emergency ones, can get through.
